WE ARE PROUD OF THE FACT THAT IN 2010 WE WERE CHOSEN TO PROVIDE BLOOD PRODUCTS TO MANATEE MEMORIAL HOSPITAL AND LAKEWOOD RANCH MEDICAL CENTER.
