IN FISCAL YEAR 2018, SUNCOAST COMMUNITIES BLOOD BANK COLLECTED 32,936 UNITS OF ALLOGENEIC RED BLOOD CELLS AND 4,405 PLATELETS 19,510 DONORS. OVER THE COURSE OF THE YEAR, SUNCOAST COMMUNITIES BLOOD BANK SUPPLIED OVER 37,341 BLOOD PRODUCTS TO THE PATIENTS IN LOCAL HOSPITALS. THIRTEEN TESTS (11 FOR INFECTIOUS DISEASES) ARE PERFORMED ON EACH UNIT OF DONATED BLOOD PRODUCTS.

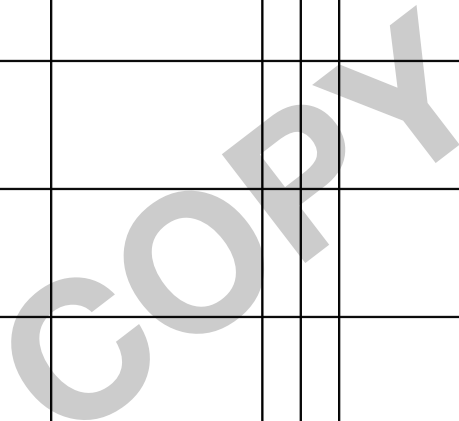
