

## OFFICIAL RULES

**Official Rules & Regulations** for the SunCoast Blood Bank (Henceforth referred to as SCBB) two-year lease drawing. SCBB is conducting the drawing pursuant to Florida Statutes to increase frequency and raise awareness about blood and platelet donation for SCBB, a registered 501 (c)(3) nonprofit. The car lease for a **2019 Ford Ranger XLT** has been generously donated by Sarasota Ford. By participating, you agree that:

These Official Rules govern the conduct of the drawing and are binding on everyone who present to donate blood, plasma or platelets. SCBB company address is 1760 Mound St. Sarasota, FL 34236. Sarasota Ford company address is 707 S Washington Blvd, Sarasota, FL 34236. The mission of SunCoast Blood Bank is to provide a reliable supply of quality blood products and services to hospitals and health centers in need.

### Rules & Regulations

The contest will begin on May 1, 2019 and end on September 8, 2019. ONE (1) Grand Prize: The winner will receive a lease for a **2019 Ford Ranger XLT** for 24 months (10,500 miles per year or 21,000 miles for 2 years). The MSRP of the winning vehicle is valued around \$29,135.00. The winner must qualify for S & A tier financing meeting all the requirements of the lender. Winner must also carry insurance as required by the lender. **Should the Winner not qualify they will receive a credit of about \$7,500 good towards the purchase of a vehicle from Sarasota Ford.** This is only good at Sarasota Ford. Winner must hold a valid Florida Driver License and proof of insurance. Prizes are not transferable or exchangeable for any other prize. Prize provided by Sarasota Ford Employee's, family members of employees and/or relatives of Sarasota Ford any Franchised Automobile Dealer registered in the state of Florida are not eligible to win. **Grand Prize Buyout Option: Should the winner not qualify for the lease, they will receive the option of a \$6,500 cash payout from Sarasota Ford less applicable federal taxes.**

The winner will receive a two-year lease of a 2019 Ford Ranger XLT. The winner assumes and must pay all fees and charges (including, but not limited to, tags and license), local, state and federal taxes when the car lease is transferred to the winner; taxes and fees of about \$1,080.66. The winner will receive a copy of the IRS Form W-2g form reporting the value of the grand prize and the amount of taxes withheld. The winner must have proper identification when claiming the vehicle (a valid state driver's license) and appropriate insurance as determined by Sarasota Ford. SCBB is not responsible for the vehicle's quality nor shall it have any responsibility once the vehicle has been conveyed or delivered to the winner. SCBB makes no guarantee that the Internal Revenue Service (IRS) will accept any stated value of any automobile for the purpose of determining any income tax that may be due from the winner. **Eligibility:** All individuals presenting to donate blood, plasma or platelets, a total of two or more units, are eligible to enter the drawing. To qualify to enter, donors can give a single unit of blood on two occasions during the contest time frame (donations must be a minimum of 56 days apart), two plasma donations (donations must be a minimum of 28 days apart), two platelet donations (donations must be a minimum of one week apart) or one double red donation. Only licensed drivers (license cannot be suspended), 18 years of age and older at time of donation are eligible to participate and enter. Individuals donating plasma or a single unit of blood will receive one entry upon their second donation. Individuals who donate platelets or a double unit of whole blood receive two entries upon each donation. SCBB may alter these requirements at any time during the contest time frame. SCBB reserves the right to disqualify any entrant for violation of these Official Rules, any applicable laws, or who makes any misrepresentations relative to this drawing of chance. The drawing may not be entered in the name of a business, trust, corporation, or other entity, or wherever prohibited by applicable law. Prize winners may be required to sign an affidavit of eligibility. SCBB Staff, members of the Board of Directors, their spouses, and immediate family are not eligible to participate.

**Entry and Tickets:** No purchase or donation of blood, plasma or platelets is necessary to participate in the drawing. Only individuals who complete a drawing form, or serve notice by letter to participate, are eligible to win. Eligibility to enter the drawing will end at 9:00 p.m. on September 8, 2019.

SCBB assumes no responsibility for lost, illegible, late, misdirected, or non-delivered entries or other failure to deliver entries prior to any deadline.

To enter without a donation, send a letter stating that you wish to obtain a “no donation” entry and include your name, address, email and phone number and a stamped, self-addressed envelope to: J. Giroux, SunCoast Blood Bank, 1760 Mound St. Sarasota, FL 34236. Only one per household. When the letter is received an entry for the drawing will be made for the individual by filling in the name, address, email and phone number on an official entry form and the contestant will be notified via mail.

#### Selection of Winner:

Names of up to 50 finalists will be drawn at random on or about noon on September 12, 2019 at SunCoast Blood Bank, 1760 Mound Street, Sarasota, FL 34236 from all eligible entries received. Finalists will be notified via phone and email from information provided on entry form and will have until September 18, 2019 at 5:00 p.m. to claim their spot in the final drawing. Any spots not claimed by that time will be forfeited and another name drawn. On or about September 28, 2019 at noon, the final drawing will be held at Sarasota Ford, 707 S. Washington Blvd, Sarasota, FL 34236. Finalist positions are non-transferable, and finalists must be present to win. A last chance blood drive will be held at Sarasota Ford the day of the final drawing from approximately 9:00 a.m. to noon. One name from those who donate at this drive will be drawn and will be considered a finalist. All official rules apply. This finalist must agree to be present at the final drawing on or about 12:30 pm at Sarasota Ford or forfeit their eligibility. All finalists must be present to win. At about 12:30 pm, a drawing from the finalists will occur in reverse order. The names drawn will be eliminated until five finalists remain. The five remaining finalists will choose a key provided by Sarasota Ford. The finalist whose key starts the car will be the winner of the two-year lease. Drawn names are not transferable; and the lease is not transferable by the winner.

Any dates/times/eligibility stated in these rules may be extended or changed at SCBB's absolute discretion. The winner must be present to win. The winner will be responsible for picking up the car and paying all taxes associated with the grand prize.
